#### New measures, subdomains, domains


Improve the breadth and composition of the Index by adding new measures reflecting social, environmental, and economic indicators of preparedness and resiliency, along with other new areas of measurement.

#### How can we integrate and meld with existing frameworks?

- RWJF Culture of Health, CDC Public Health Emergency Preparedness (PHEP), DHS/FEMA target capabilities, ASPR National Health Security Strategy (NHSS), Presidential Policy Directive 8: National Preparedness Report
  - Improve Index alignment with established national frameworks for preparedness and health security, particularly those frameworks used by USDHHS and USDHS agencies and relevant state and local agencies.


### Tasks and Timeline

## **Model Design Work Group**

- Subject matter experts in health security, preparedness and resiliency theory, policy and practice.
- Refine and update the conceptual model of health security and preparedness that provides a theoretical and structural foundation for the Index.
- Ensure that key constructs related to health security, preparedness and resiliency are reflected in the Index's domains, subdomains and individual measures.



## Ideas Suggested for New Measures


- Expand social, environmental economic indicators of preparedness & resilience
- Prior workgroup recommendations:
  - Pre-event community status
  - Federal contributions to preparedness
  - Congregate care
  - Fatality management
  - Outpatient care
  - Non-pharmaceutical interventions
  - Responder safety and health



## Ideas Suggested for New Measures, cont.

- JCAHO compliance rates with emergency management standards: hospitals, nursing homes, home health, behavioral health
- Infrastructure reliability: power, water, transportation, communication, housing, public facilities
- Geofeedia data on social network communication signals: community concerns, resources
- Workplace policies: PTO, telecommuting
- Cybersecurity measures
- Inter-sectoral & inter-jurisdictional collaboration measures
- Preparedness funding levels & distribution


