# **Call for Measures Input**

#### Measures for which data are available to implement now

- Percentage of 1-person households
- Population service by comprehensive public health system
  - Modify M501 by focusing on vulnerable population
- State health agency has at least a level 1-2 designation to test for chemical threats
- {Number of} environmental health specialists {per 100,000 population}
  - BLS OES 19-2041 Environmental Scientists and Specialists, Including Health
- Adoption and meaningful use of electronic health records (EHR)
- Rates of injury, illness, mental/behavioral effects, exposure, or mortality of first responders as a result of deployment during an incident / Or, does the state monitor first responders for signs of negative physical, emotional, or mental effects?



#### Measures requiring additional study

- Mosquito Control areas in a state/State vector control program capacity
  - Latest CSTE report published in 2014 (2012 data)
- State has capacity of investigating environmental health illnesses, disease and injuries and is capable to respond to emergencies
  - 2013 CSTE report would require some specification work—several measures
- Does your (state public health) laboratory provide pre-positioned mobile chemical/biological decontamination technology to prepare and respond to disease outbreaks and chemical attacks and exposure events?
- Percent of residents that perceive the most people in their neighborhood as trustworthy & percent living in close-knit neighborhood
  - CPS, Civic Engagement Supplement (2013 data, updated in 2017)



#### Measures requiring additional study

- State-level mass fatality plans
  - Yes/No? Continuum?
- Degree to which each state has a critical infrastructure plan preparing and protecting them from cyber-attacks – especially for the healthcare structure.
- Number of environmental health specialists who have completed the various courses (e.g., EHTER awareness, EHTER operations courses, Epi-Ready training courses)

#### Number of personnel who have been trained for various skills/tasks

- Community Assessment for Public Health Emergency Response (CASPER) surveys; it is a statistical analysis method developed by the CDC to assess human health needs after a disaster.
- Emergency Responder Health Monitoring and Surveillance (ERHMS) course
- Assessment for Chemical Events (ACE) course



#### Measures requiring additional study

- Does the state have a standardized safety officer training and certification programs
  - (e.g., NFPA 1500; FEMA E954: All-Hazards Position Specific Safety Officer) for responders (fire, law, emergency medical services, hazmat, and public health).
- Number of illnesses/outbreaks reported to CDC
  - Vector-borne illness outbreaks reported to the CDC Arbo-Net
  - Water-borne illness outbreaks reported to the CDC
- Does your health department have a deployment safety and health program for public health staff who report for duty during an incident?
- State has written guidance for Local Health Officers on nonpharmaceutical interventions (isolation, quarantine, decontamination)
- State has a written radiological emergency plan that includes activation of centers for screening and decontamination of survivors
- State has a written disaster plan for patient movement



#### Measure ideas we can use in other ways (e.g., blogs)

- Human Development Index
- Increasing prevalence of anti-microbial resistance



## **Other Measures**

- Occupational Health
  - Emergency Responder health/fatalities
    - Bureau of Labor Statistics (BLS) Census of Fatal Occupational Injuries
      - Police, Fire, Ambulance, Emergency & Relief Services
- Health Care Coalitions (HCCs)
  - Working with personnel at ASPR to specify measure and acquire data
- Individual Level Measures of Preparedness
  - FEMA National Household Survey, 2015
    - July 2015, 5,000 respondents, questions on preparedness and awareness of actions (e.g., plan, supplies)
    - Doesn't support state-level estimates, yet
  - HUD American Household Survey
    - National estimates only
  - There are no state-level estimates available
    - But, we might want to include for national level estimates



# **Geographic Additions**

- Data are widely available on many measures for ...
  - Territories
    - PR, others
  - Cities
    - DC, NYC, Chicago, LA
- As we collect data for the 2017 NHSPI, we are also collecting data, where available, for territories and cities
- We are likely to convene a special workgroup in 2017 to evaluate progress and advise on next steps
  - Post 2017 NHSPI release
